

## **JUNE DOUBLE COMMISSION REFUND PROMOTION**

BROKSTOCK clients who fulfil the below criteria during the promotional period are eligible to receive a double refund on commission fees related to buy transactions, subject to the terms set out herein.

### **Promotion Requirements**

The promotion is valid exclusively for new funds deposited into the client's BROKSTOCK account.

Clients who, on any calendar day in June 2025, deposit an amount equal to or greater than R100,000, qualify for a 7-day double commission refund period.

Within 7 days following such a qualifying deposit, if the client executes buy transactions on any instrument using the deposited amount, BROKSTOCK will refund double the commission fee on these buy transactions.

Only the first eligible set of buy transactions up to the deposit amount will qualify for commission refund.

The promotion can be triggered multiple times during the month. Each new qualifying deposit of R100,000 or more starts a new 7-day double commission window.

### **Reward Receiving**

The maximum total refund available to any one BROKSTOCK client during the entire promotion period is R50,000.

Refunds will be calculated and processed between 15 July and 30 July 2025.

In order to be eligible for the refund, the client's asset balance from 1 June to 30 July 2025 must remain equal to or above the total qualifying deposit amount(s). If multiple qualifying deposits occur, the total balance must not fall below the cumulative total. Otherwise, only the highest eligible deposit that meets the balance condition will be considered.

### **Promotion Period**

This promotion is valid from 1 June to 30 June 2025. The last day for eligible transactions is 30 June 2025.

## **Other Terms**

All qualifying buy trades must be executed via the BROKSTOCK platform.
