

## STOCKS GIVEAWAY PROMOTION FOR BROKSTOCK CLIENTS

This promotion is open to all existing clients of BROKSTOCK who hold a valid account with us. New clients must open an account to be eligible for this promotion.

Below are the terms and conditions for entering the promotion held by BROKSTOCK with a chance to win 1 of 5 different stocks worth up to R15 000.

To enter the promotion the participant must:

- be over the age of 18;
- have the BROKSTOCK trading account;
- deposit R 10 000 or more into trading account before 1 August 2024;
- the participant can make a deposit in several transactions, the total amount of deposits during the promotion period is taken into account;

Depending on the total deposit amount, there are 5 categories for which 5 gift stocks are defined:

R 10 000 – 49 000 – NVIDIA NVDA;  
R 50 000 – 99 000 – Amazon AMZN;

BROKSTOCK shall have no liability for Winner's failure to receive notices due to spam, junk e-mail, or other security settings or for Winner's provision of incorrect or otherwise non-functioning contact information. Gift stock will be credited to the client's trading account within 14 business days after the end of this promotion.

## **Other Terms**
