

BROKSTOCK ANNIVERSARY PROMOTION

BROKSTOCK SA (Pty) Ltd, authorised by the Financial Sector Conduct Authority under FSP number 51404, offers this anniversary promotion to eligible BROKSTOCK clients. Clients with an active and valid account who fulfil the requirements of this promotion are eligible to receive a temporary Package level benefit in celebration of BROKSTOCK's anniversary. These terms apply to existing clients and to new clients who open an account and meet the promotion requirements during the Promotion Period.

ELIGIBILITY

To participate in the promotion, a client must:

- be at least 18 years old;
- hold an active, verified, and valid BROKSTOCK account;
- have at least one successful deposit recorded on the BROKSTOCK platform, whether before or during the Promotion Period;
- confirm receipt of the anniversary gift on the promotion landing page in the BROKSTOCK application during the Promotion Period

If a client has previously made a successful deposit, the client may request and receive the gift through the landing page without making an additional deposit. If a client has never made a successful deposit, the client must make a successful deposit of any amount during the Promotion Period in order to participate.

PROMOTION REQUIREMENTS

A deposit is treated as successful only once it has been accepted, processed, and reflected by BROKSTOCK's systems. Deposits that are reversed, cancelled, rejected, charged back, or otherwise not completed do not qualify for the promotion.

Multiple accounts, identities, devices, phone numbers, email addresses, or other methods may not be used to obtain more than one reward. The landing page will be available in the BROKSTOCK application to all clients. Confirmation through the landing page is required for the reward to be allocated.

REWARD RECEIVING

For clients whose current Package level is Basic, Bronze, Silver, Gold, or Platinum, the reward is a temporary upgrade to the different Package level above the client's current Package level as determined at the time the gift is received. This promotion is valid from 1 July 2026 to 31 July 2026. To qualify, the client must meet the applicable eligibility requirements and confirm receipt of the gift through the BROKSTOCK application during this period.

OTHER TERMS

This promotion is available only to clients who meet the eligibility, deposit, and confirmation requirements set out in these terms.

The reward is personal to the eligible client, is non-transferable, and cannot be exchanged for cash or any alternative reward unless BROKSTOCK decides otherwise at its sole discretion.
