

DAILY EFT DEPOSIT PROMOTION FOR BROKSTOCK CLIENTS

BROKSTOCK clients with an active account who fulfil requirements of this promotion are eligible for the opportunity to receive stock CFD as a gift.

Promotion Requirements

The client should make a deposit during the promotion period via EFT (Electronic Funds Transfer) to qualify for participation. EFT means an electronic bank transfer from the client's personal bank account to their BROKSTOCK account.

Only deposits above ZAR 10,000 qualify for this promotion. Deposits made using any other method will not be considered.

The promotion is structured as a daily competition. For each day of the promotion period, the client who makes the largest qualifying deposit will receive one (1) stock CFD.

Deposits are counted based on the date they are credited to the client's BROKSTOCK account, not the date they are initiated, as processing times may vary. If a client makes multiple deposits within the same day, only the largest single deposit will be considered for that day. In the event that two or more clients make deposits of the same amount on the same day, the client whose deposit is credited first will be deemed the winner for that day.

Only one (1) gift stock CFD may be awarded to one client during the entire promotion period.

Prize

A total of six (6) gift stock CFDs will be awarded during the promotion period. Prizes are awarded based on six (6) qualifying business days within the promotion period. Non-business days, weekends, and public holidays may be excluded from prize allocation at BROKSTOCK's discretion.

Each winning client will receive one (1) stock CFD selected from the following:

The specific stock CFD awarded is selected randomly from the pool listed above. BROKSTOCK does not guarantee which specific instrument will be allocated to any particular client.

The value of the stock CFD may fluctuate depending on market conditions.

Reward receiving

Gift stock CFD will be credited to the client's investing account no later than April 10, 2026, following verification of all qualifying deposits.

Gift stocks are provided in the form of a CFD (Contract for Difference). Therefore, the nominal amount represents exposure to the underlying asset and not ownership of the actual share. The client may profit or incur losses based on price movements but does not acquire ownership rights.

Promotion Period

This promotion is valid from March 24, 2026 until March 31, 2026 (inclusive).

Other Terms

This promotion is available to all clients who meet the deposit criteria within the specified period. BROKSTOCK reserves the right to determine eligibility at its sole discretion.

Prize validity period is 90 days. During this period the winning stock must be sold by the client. After this period expires, if the stock is not sold, it will be automatically returned to BROKSTOCK.
