

OCTOBER COMMISSION CASHBACK PROMOTION

BROKSTOCK clients who meet the eligibility criteria below during the promotional period may qualify for a cashback on trading commission fees, in accordance with the terms outlined herein.

Promotion Requirements

- The promotion is valid exclusively for **new funds** transferred into a client's BROKSTOCK account during the promotional period.
- The commission cashback applies to existing account balances and newly deposited funds.
- Clients who make qualifying net deposits in **October 2025** will be eligible for a cashback on commission fees, according to the following tiers:

Net Deposit Range	Commission Cashback
R20,000 – R99,999	15% Cashback
R100,000 – R299,999	20% Cashback
R300,000 – R499,999	25% Cashback
R500,000 – R999,999	30% Cashback
R1,000,000 and above	30% + 5% plus optional special personal offer (to be confirmed with your account manager)

- To remain eligible, clients must maintain the qualifying balance until **30 November 2025**.
- Withdrawals made during **October and November** are permitted, provided the net deposit balance remains within one of the qualifying tiers. (Net Deposits = Deposits – Withdrawals). Only balances equal to or greater than R20,000 / R100,000 / R300,000 / R500,000 / R1,000,000+ will qualify.
- To participate in this promotion, the client must first click the "Participate" button on [landing page](#) in the BROKSTOCK App or platform. Cashback will only be calculated for clients who have successfully registered their participation during the promotion period.

Cashback Allocation

- The account balance as at **30 November 2025** must still reflect the required qualifying

net deposit amount.
