

BROKSTOCK Referral Challenge Terms & Conditions

General Provisions

These Terms and Conditions govern participation in the BROKSTOCK Referral Challenge ("the Campaign") conducted by BROKSTOCK SA (Pty) Ltd, a company incorporated in accordance with the laws of South Africa. This Campaign is open to all BROKSTOCK users who meet the eligibility criteria described below.

The Campaign shall commence on the date of publication and shall run until 31 August 2025, unless extended or terminated at the sole discretion of BROKSTOCK SA (Pty) Ltd. The Campaign is open to all BROKSTOCK users who meet the eligibility criteria described below.

Participation in the Campaign constitutes acceptance of these Terms and Conditions.

Eligibility Criteria

Participation in the Campaign is open to verified BROKSTOCK users residing in South Africa.

Users must share their unique referral link to invite friends to the platform.

A referral shall be deemed successful only if the referred individual:

1. Registers via the dedicated BROKSTOCK referral landing page using the referral link <https://brokstock.co.za/invite/#register>;
2. Downloads the official BROKSTOCK mobile application;
3. Enters the same phone number used during signup under the referral link;
4. Makes a minimum deposit of R5 000 within seven (7) calendar days from the date of registration;
5. Executes one or more investments worth not less than R5 000 within the same 7-day period.

These actions must be performed in the strict order listed above.

No more than two (2) referred users Sharing the same surname (or otherwise clearly identifiable as immediate family members) may participate in the Campaign per referring user. Any additional referrals beyond this limit will be considered at sole discretion of BROKSTOCK.

If any of these conditions are not met in full, the referral will not be considered successful.

At the time of bonus issuance, the client's asset balance (calculated as total deposits minus total withdrawals) must be at least R1 000 or more. If this requirement is not met, the prescribed bonus will not be credited.

Reward Structure

Base Reward

For each successful referral, both the inviter and the referred user will receive a reward of R1 000, subject to the fulfilment of all eligibility criteria.

Referral rewards shall be calculated on a monthly basis and disbursed at the beginning of the following calendar month, provided that all eligibility criteria have been met.

Leaderboard Challenge

An additional prize pool of R100 000 and ten (10) Gift Share CFDs (valued up to R1 000 each) will be distributed based on two independent leaderboards:

- **Leaderboard A** – *Number of referred users*
- **Leaderboard B** – *Net assets balance brought in by referred users*

Leaderboard Scoring

Points are awarded only for users who meet the conditions listed above.

All activity is tracked and calculated until 7 September 2025.

Example for transparency:

A referred user made three deposit transactions of R100,000 each on different dates:

- R100,000 – 5 August (Deposit)
- R100,000 – 10 August (Withdrawal)
- R100,000 – 31 August (Deposit)

As of the final calculation date on 7 September, the prize is calculated on the net assets balance of R100,000.

Withdrawals made by referred users between 8–15 September 2025 will disqualify them from leaderboard scoring.

A single participant may be eligible for rewards in both leaderboards (e.g., 1st in referrals and 2nd in net-assets balance).

Participants who place between 6th and 10th position on a leaderboard will each receive one (1) Gift share CFDs for that leaderboard.

A participant who places between 6th and 10th position on both leaderboards will therefore receive a total of one (1) Gift share CFDs .

If fewer than 10 participants qualify, prizes will be distributed among the eligible top scorers only.

Technical Requirements

The leaderboard displays anonymised participant IDs (6 digits).

Live leaderboard updates will display top ten (10) participants and indicate each participant's current standing. Participants who are not in the top ten will be able to check their individual ranking.

The leaderboard functionality shall become active once at least ten (10) participants meet the eligibility criteria.

Reward Receiving

All rewards (base and leaderboard) will be credited to BROKSTOCK accounts within 20 business days following the Campaign closure.

Miscellaneous

If the client uses fraudulent methods or otherwise attempts to circumvent the rules, they may be removed from eligibility at the sole discretion of BROKSTOCK.

Gift Share is held in the form of a CFD (Contract for Difference). Therefore, the nominal amount represents the value of the exposure, not ownership of the actual stock. The client only gains exposure to the nominal value, meaning they can profit or incur losses based on the price movements of the stock, but the client does not take ownership of the underlying asset.

Gift validity period is 90 calendar days. During this period the winning stock must be sold by the client. After this period expires, if the stock is not sold, it will be automatically returned to BROKSTOCK.

By participating, you agree to be fully unconditionally bound by these terms and conditions, and you represent and warrant that you meet the eligibility requirements. In addition, you agree to accept the decisions of BROKSTOCK as final and binding as it relates to the content of this promotion.
